Meeting called to order at 12:02 p.m.

Public Comments regarding Agenda items: None.

Review/Discussion/Action – Minutes of the April 20, 2022: Mr. Rynders accepted motion to approve minutes as presented, seconded by Ms. Lieftring. Motion carried.

CJCC Financial Report: The CJCC financial report was presented with a balance of \$39,350.80 (see below). There is not much change.

Mr. Osmond wanted to discuss the parameters as to how the CJCC money can be spent. Mr. Osmond and Ms. Berning met and did not see anything in the bi-laws that states a criteria for spending and suggested forming a sub-committee. Mr. Brooks volunteered to begin the sub-committee and anyone who wants to participate can send an email to Mr. Brooks. Judge Clark made a point that the money should not be spent just because CJCC has it. It should be spent on something that can enhance the programs goals or benefit the program to meet its needs. When the sub-committee meets and has some ideas on how the money can be spent, it can be put as an agenda item. Mr. Schmidtknecht accepted motion to approve the financial report as presented, seconded by Ms. Lieftring. Motion carried.

Community Work Service (CWS) Report: Ms. Rieck sent out report (see below). Activity has been slow, and District Attorneys have not been asking for it. Mr. Schmidtknecht accepted motion to approve the community work service report as presented, seconded by Ms. Lieftring. Motion carried.

Inmate Status Report: (see reports below).

Buffalo County: Mr. Olson reports there are currently ten inmates in the Buffalo County jail and five are on electronic monitoring (see below).

Pepin County: Mr. McMahon was not present during the meeting. There are currently seven inmates in the Pepin County jail (see report below).

Mayo Hometown Health Grant Application: Mr. Rynders informed the committee, Mayo will be making their announcements this week if Buffalo County has been awarded the grant. Mr. Rynders will inform the committee once he hears from Mayo.

Moving Forward (Jail Reentry) Program Report: Ms. Campbell Wood was not able to be present at the meeting and will put on for next meeting's agenda.

CJS Coordinator Report: Ms. Berning was not able to be present at the meeting. Ms. Bautch presented the final March 2022 financial statement (see below).

Ms. Bautch presented the 1st quarter TAD revenue. The 1st quarter money was received. The new TAD management has been working to improve the quarter reports and they have become more extensive. Ms. Berning and Ms. Bautch worked to obtain all the data TAD needed. All the data they required was information entered into the CORE data entry system, but those reports are not available. This concern was included in the 1st quarter TAD report. Ms. Bautch read the positive email that was received from the new TAD manager stating their gratefulness with the report and how well it was done with the data, details and it was well organized. They will be looking into running those new reports out of CORE. They also commended Ms. Bautch and Ms. Berning for their regular and consistent data entries into CORE.

Ms. Bautch reviewed the CJS data report (see below).
